Draw dates - Monday, March 29, 2010, for trials and Monday, April 12, 2010, for finals, 4:00 p.m. at race track office. 15% of purse will be deducted for administrative and advertising purposes. All added money will be paid to the horsemen. \$20.00, 2010 dues at Dixie Downs must be paid with nomination on January 1, 2010. Subject to the Utah Horse Racing Commission and the St. George Lions Club Rules and Regulations.

All Trainers, Owners, Jockeys and Grooms must be licensed with the Utah Horse Racing Commission.
